Procedural order

Submission of an application

An application for a worker's or a repairer's employee's approval (manufacturer, distributor, repairer) shall be submitted to the police headquarters whose jurisdiction covers the organization's or the individual enterprise's workplace, the Budapest Police Headquarters in Budapest.

If the same organization or individual enterprise has two or even three different authorizations for activities, the employee applications shall be submitted separately for each activity.

Costs and expenses of the procedure

The administrative service fee for the employee approval application is HUF 2000 per person. In the case of a repair employee the administrative service fee shall be paid to the appropriation allocation fund account of the county police headquarter in charge of the case initially; in Budapest, to the Metropolitan Police Headquarters. In the case of a manufacturer or distributor, in the first instance to the county Police headquarters; in Budapest, to the appropriation allocation fund account of the Budapest Police Headquarters. The payment must be made no later than the day following the date of receipt of the registration number of the competent authority. The notice should indicate the reason for the payment for "alkalmazotti kérelem gyártáshoz, forgalmazáshoz, javításhoz" ("employee application for production, distribution, repair") and the case number. (Registration number: RZSEIR registration number indicated on the notification sent by the document management system of the police to the applicant's Customert Gateway storage space).

The account numbers are listed in Appendix 2 of the R.

PDF file attachment(s) to be added to the application

- a certificate attesting the qualification of production, distribution or repair.

The applicant shall present the original document(s) enclosed at the request of the authority.

Processing an application

If the application is submitted in full to the competent authority or the applicant has fulfilled the authority's request for correction and the application complies with the legal requirements, the authority shall issue an authorizing decision. The electronically authenticated decision will be issued and sent by the police to the applicant. The authority issues a card to an employee authorized to carry out a manufacturing, distribution or repair activity, which, according to the client's declaration, is delivered by post or handed over in person during customer reception hours.
