#### Procedural order

##### Submitting an application

The declaration on firearms, weapons, ammunition and cartridges held in storage by an authority shall be submitted to the Police authority which is responsible for the location where the storage or secured storerooms are situated.

**Costs and expenses of the procedure**

The procedure is free of charge.

No attachment to the application is required.

**Processing the application**

If during the processing of the application, it is established that the eligible customer has submitted the application in full to the relevant authority and the statutory conditions for authorization are met, the electronically authenticated decision shall be issued and sent by the Police to the applicant. In the course of the procedure, a personal appearance is not required.
