#### **Submitting the statement**

The holder of the manufacturing authorisation has to submit to the authorising authority a statement on the pyrotechnical articles it has manufactured in the previous year, by product type, by 15 February each year.

The holder of the distribution authorisation has to submit to the authorising authority a statement on the pyrotechnical articles it distributed in the previous year, by product type and by quarter, by 15 February each year,.

Statements on products distributed on the basis of a year-end authorisation are to be submitted to the authority issuing the distribution authorisation valid until further notice.

The statement may also be submitted electronically, as an attachment to the form.

## **Processing the statement**

The authority that has issued the authorisation shall assess the contents of the form submitted and its attachment.

The authority shall not send its decision or any notification to the customer concerning statements taken note of. The authorising authority shall send the statement to the relevant fire-fighting authority.

In justified cases, the authority initiates a procedure, or requests the customer to supply missing information. The customer can supply the information thus requested using the RHIP-001 ÁNYK form.
