#### Procedural order

# Submitting an application

An application for the installation and use of a warning device may be considered on the basis of the place where the activity is carried out or where the applicant's domicile or headquarters and the relevant police headquarters are located in the following types of cases regarding vehicles that:

- regularly accompany a vehicle transporting radioactive material or that exceeds the length or width of a vehicle that is permitted by separate legislation,
- tow damaged vehicles or regularly carry out roadside repair of a broken-down vehicle on the road, as well as
- are used for the authorized transportation of vehicles and for the regular use in the course of applying wheel clamps,
- are used in the supply of money and valuables, performing regular security activities, operated by a financial service organization.

- a copy of the document certifying the act on behalf of an order
- a copy of the document certifying the operation and use of the signal

(The client has the means to certify any data that may not be required, on the basis of the General administrative order, to file a document.)

### Costs and expenses of the procedure

The fee for the application is a procedural fee of HUF 3,000 - (three thousand) In the first instance, the fee shall be paid by transfer to the account number of the county police headquarters whose jurisdiction covers the relevant police station and in Budapest at the Budapest Police Headquarters' account number with advance payment or subsequent payment.

- 1. Account number: Listed at the end of this Information.
- 2. Preliminary payment: In the section of reference, the word "figyjel" and the name of the organization / person performing the activity shall be indicated.
- 3. Subsequent payment: At the latest on the day following the date on which the proceeding authority's registry number is known. In the reference section of the transfer, the filing number of the case shall be indicated. (Filing number: RZSEIR registration number indicated by the police records system and then notified in the Customer's Gateway storage space)

### **Processing an application**

The relevant authority shall decide on a comprehensive procedure within eight days of receipt of the application if the application is complete and the conditions for authorization are met by the applicant.

If the application or the attachments thereto are incomplete, the authority issues a request for additional information within 8 days of the receipt of the application - indicating an appropriate deadline and warning of the legal consequences. The final decision will be taken after the submission of the additional information.

The applicant shall be exempt from the duty on the basis of Act XCIII. of 1990 on duties in cases specified by law, of which he shall give a declaration at the same time as he submits the application.

The electronically authenticated decision shall be issued and then sent by the Police to the customer who applied for it. During the process, no personal appearance is required.
