#### Procedural order

#### Submitting an application

The shooting range operator with an operating licence shall submit the notification to the police headquarters relevant to the location of the shooting range; if in Budapest, this will be to the

Metropolitan Police Headquarters, within the timescale established by the Ministry of Interior decree.

## Costs and expenses of the procedure

The procedure is free of charge

No attachment to the application is required, unless the details of the firearms to be used in the practice shooting are enclosed..

## Processing an application

The authority shall take note of the application. No separate acknowledgement will be sent to the applicant. No personal appearance is required during the processing.
