Procedure

Operating a shooting range is permitted to sports associations, business entities or branches of business enterprises having their registered seat in another country which is a party to the Agreement on the European Economic Area, recorded or registered in Hungary.

Submitting the application

The application for the licence to operate a shooting range for civilian use must be submitted to the relevant police department of the location of the shooting range; in Budapest, the Budapest Police Headquarters.

Costs and expenses of the procedure

The administration service fee payable for the application for the licence to operate the shooting range shall be HUF 50,000.

The administrative service fee is payable to the appropriation allocation bank account held by the relevant county police headquarters in charge of the police department initially involved; in Budapest, the Budapest Police Headquarters.

The administrative Service Fee can be paid by bank transfer or via the Electronic Payment and Settlement System (EFER) via online bank card payment (VPOS).

In the case bank transfer, the information field must contain the purpose of the payment e.g. ,, application for a licence to operate a shooting range" and the registration number returned after the automatic registration, which is a case number consisting of the following positions:

Attachments to be added to the application submitted in pdf files

1. Designation of shooting range: temporary field, permanent field, built-in shooting range;

[Off-road: With few structures, mostly natural bullet catchers

Built shooting range: With more or less superstructures (eg indoor shooting range, built-in bullet catcher, signaling position)

Built-closed shooting range: eg. cellar shooting range]

- 2. Location (exact address) of the shooting range, ground plan of the shooting range, map of adjacent land parcels;
- 3. Marking on each shooting range that the shooting range
 - the nature, caliber and category of the firearm or museum weapon, and
 - what purpose (training, competition, education, gun firing, skeet, trap, puck hunter, running game, point, etc.) do you want to use;
- 4. If the applicant is not the owner of the area concerned, the consent of the owner of the area concerned to the operation of the firing range;
- 5. A valid liability insurance contract for the operation of the shooting range as a hazardous operation
- 6. Forensic weapons expert opinion (danger area)

- 7. Proof of payment if the administrative service fee is paid in advance.
- 8. Shooting Range Rules in Word format (Annex 3 to Regulation)

The application, if available, may be accompanied by:

Forensic Expert Noise Report, which includes the actual number of meters from the <u>unobstructed boundary</u> of the firing range, including the nature of the firearms, the caliber, the range and <u>the intended use</u>, of the environmental noise impact area.

- In the proceedings, sectoral legislation [Kr. 5 / B. (4) of the Act] by virtue of the power of the client other than the applicant: the owner of the property within the scope of the shooting range as well as the person whose right to the property is registered in the land register.
- Impact area: The unencumbered enclosure of the shooting range and X meters from its boundary (determined by the expert).

The applicant may attach the expert's opinion, in which case the expert does not have to be seconded to the procedure (procedural cost, administrative time).

Processing the application

If during processing the application it is established that the entitled applicant has submitted the complete application to the authority having appropriate jurisdiction, or the applicant has complied with the request for correction or amendment, and that upon the site inspection carried out, the shooting range has met the requirements set forth in D., and furthermore, there are no grounds against the applicant in the Arms Act for refusal of granting the licence, the authority shall grant the licence to operate the shooting range in a form of a decision. The Police shall then send the applicant the electronically certified copy of the decision (licence). During the procedure no personal appearance is required when taking receipt of the permit.
