## **Procedure**

### **Submitting the application**

Applications for the authorisation for employee approval are to be submitted to the police headquarters whose jurisdiction covers the applicant's place of residence; in Budapest, to the Budapest Police Headquarters.

### **Costs and expenses of procedure**

The administrative service fee for applications for employee approval is HUF 2,000.

For change of name or other data the administrative fee is HUF 3,000.

For change of employee's name of manufacturer, distributor, repairer the administrative fee is HUF 3,000 (basic fee) + HUF 2,000 per employee.

The application for termination of employment is free of charge.

The administrative service fee is to be paid in advance or ex-prior into the appropriation allocation fund account of the county police headquarters in charge of the local police headquarters proceeding at first instance; in Budapest, the Budapest Police Headquarters.

The administrative Service Fee can be paid by bank transfer or via the Electronic Payment and Settlement System (EFER) via online bank card payment (VPOS).

In the case bank transfer, the information field must contain the purpose of the payment e.g. „Application for the authorisation required for employee approval” and the registration number returned after the automatic registration, which is a case number consisting of the following positions:

### **Attachments to be added to the application in pdf format**

In the case of an application for employee approval

- an examination certificate of the acquisition of the theoretical knowledge and practical skills required for holding firearms;
- a certificate of qualification for manufacture, distribution, repair;
- a certificate of a medical aptitude examination (issued by a body authorised for occupational health examinations).

In the case of a request for change of data:

- a document justifying the change.

### **Processing the application**

If the applicant has submitted a fully completed application to the relevant and competent authority, the authority shall issue an electronically certified decision and shall send the decision to the applicant. No personal appearance is required for the receipt of the decision.
