### **Submitting the application for termination**

The application for the termination of the activity has to be submitted to the city (district) police headquarters whose jurisdiction covers the applicant's place of residence, place of stay, or in the absence of such, their address for notices; and in the case of an enterprise, its registered office/ establishment or branch.

### **Costs and expenses of procedure**

The application may be submitted free of charge.

### **Attachments to be added to the application**

The original licence, operating licence or certificate issued by the authorities to authorise the pursuit of the activity, which is to be sent by post or delivered in person to the relevant law enforcement authority in charge.

### **Processing the application**

Within 8 days of receiving the application, the Police shall take measures to have the licence, operating licence or certificate withdrawn.

In view of the fact that in the case of the termination of an activity, the original, still valid licence/ operating licence/ certificate needs to be submitted to the Police, a personal appearance may be required during the procedure.
