#### **Procedure**

### **Submitting the application**

The technical certificate must be submitted to the relevant police department of the place of residence of the person or of the place of activity of the legal entity having a licence to possess firearms; in Budapest, the Budapest Police Headquarters regarding:

- gas and alarm weapons for the purpose of self-defence;
- theatrical weapon;
- on-duty firearms and firearms for sports, target practice and hunting.

The technical certificate must be submitted to the relevant county police department of the place of activity of the legal entity having a licence to possess firearms; in Budapest, the Budapest Police Headquarters regarding firearms of:

- personal and property protection;
- work (category "A" and mufflers);

- film production (category "A").

## Costs and expenses of the procedure

The procedure is free of charge.

 the issued valid certificate related to the inspection carried out by the organization designated to inspect firearms and ammunition

## **Processing the application**

The authority records in its register the new period of validity indicated in the inspection certificate, of which it will not send any notification. Upon sending the police authority the technical certificate, the customer has fulfilled his/her obligation as prescribed by law.
