The examination questions on weapons knowledge are contained in Annex 1 of the BM Decree, the examination questions prescribed for the installation and reloading of domestic ammunition are contained in Annex 2 of the BM Decree, and the examination questions on arms distribution are listed in Annex 10 of the Kr.

Submitting the exam application form:

The application form for the exam must be forwarded to the county (capital) police headquarters.

Exam fee:

- Weapon knowledge exam: 10 000 HUF
- Arms distribution exam: 10 000 HUF
- Exam for home ammunition assembly and refilling: 10 000 HUF

The exam fee must be paid per exam.

The fee must be paid to the appropriation utilization framework account of the county (capital) police headquarters conducting the examination before appearing for the examination. The fee can be paid by bank transfer or cash transfer order (check). In case of transfer or payment by check, the case number must be indicated in the notification box. The case number will be communicated by the authority in an automatic reply to its location following the electronic submission of form RI-0655. In the case of an application form for an examination submitted on paper (in person or by post), the authority will provide the case number in the notice of the date and place of the examination.

The examination for the knowledge of weapons, the examination for the distribution of weapons and the examination prescribed for home ammunition and reloading may be attended by, who has paid the examination fee and presented the check slip certifying the payment of the examination fee or, in the case of a transfer, the bank statement certifying the executed transaction at the place of the examination.

You do not need to attach an appendix to the exam application form.

Processing the application form for the exam:

The county (capital) police headquarters organizing and conducting the examination shall inform the candidate for the examination of the place and date of the examination.
