#### Procedure

##### Submitting the application

The technical certificate must be submitted to the relevant police department of the place of residence of the person having a licence to possess firearms; in Budapest, the Budapest Police Headquarters.

##### Costs and expenses of the procedure

The procedure is free of charge.

**Attachments to be added to the application submitted in pdf files**

- the valid and issued certificate on the inspection carried out by the organization designated to inspect firearms and ammunition
- the certificate issued on the completion of the target practice

**Processing the application**

The authority records in its register the new period of validity indicated in the inspection certificate, review the content of the certificate and take note of the information contained therein, of which it will not send any specific decision or notification to the. Upon sending the police authority the technical certificate or the certificate on the completion of the target practice, the customer has fulfilled his/her obligation as prescribed by law.
