# FROM THE ORDER OF THE BARABAS BORDER CROSSING POINT'S PROVISIONS CONCERNING THE PASSANGERS

The order of the border crossing point determines that obligatory featured directions which should be kept by inspecting officers and the passengers for the safe and smooth implementation of the border control.

# The following are the order of the Bordes crossing point's provision concerning the passengers:

### 1. General features of border crossing point

The border crossing point is open for the international passenger traffic, and for the Local Border Traffic Agreement persons using travel document in the local border traffic control. The crossing point is **open from 07:00- till 19:00.** 

The territory of the border checking point is surrounded by fence. The board of Barabás Border crossing point and the barrier is shows the beginning and the end of the border checking point.

#### 2. The organisations which take part in the border check

- Barabas Border Police Office
- National Customs and Excise Office Szabolcs-Szatmár Bereg-County Customs and Excise Direction Beregsurány Border Office (thereinafter CEO)

#### 3. Persons have a right to cross the border

- According to the Schengen Code persons travelling in the international traffic using travel document,
- According to the local Border traffic Agreement persons using travel document in the local border traffic control,
- Persons having other documents to cross the border according to the international agreements or laws
- Vehicles which have different feature from the regular traffic and their passengers with special permission,

Persons may cross the border on foot, by bicycle by motor-cycle, by passenger car,

#### 4. The order of control of persons and vehicles and their passage:

- Those who have free movement can use the EU, EEA, CH and ALL PASSPORTS traffic lane.
- Everyone else have to use the ALL PASSPORTS traffic lane.
- In the event of a temporary uneven distribution of traffic at the border crossing point, the Police may suspend the rules for the use of the traffic lanes for the necessary time to eliminate the uneven traffic.
- In the interest of closing border crossing point Police can stop the enter into the crossing station. After close the crossing station police deny the passage

#### 5. Border checks:

The traffic control happens in the passenger's arriving order.

At the border crossing point, the persons and vehicles applying for the border crossing are checked and crossed in the passenger's arriving order.

#### Check order for enter traffic:

The control of passports and other travel documents by the Police and the customs control by a customs officer are carried out in parallel with the provisions of Decree 29000 / 16779-69 / 2019. by. The procedure is done according to one-stop technology.

Check order for exit traffic:

- Control which is implemented by the police contains the passport and other document and vehicle checking.
- Customs officer control (as required).

## Border crossing out of turn:

The control in the case of the persons enjoying diplomatic or other exemption may be different. According to the 9/Aof the 332/2007. (XII.13.) government decision of border control can be implemented out of turn- by application- by relevant economic, public, medical or cultural interest related to the border crossing. The authorizer is the duty officer of Szabolcs-Szatmár-Bereg County Police Headquarters.

#### **Obligatory directions concerning to the passengers:**

- Passengers applying for border crossing have to transmit their travel documents and other documents necessary for control to the police officer.
- Passengers under control have to stay in the cars, till other instruction of the police or customs officer.
- By the inspection of the cars the driver of the car have to follow the instructions of the officer on duty
- Authorities and transport company's product which provided with security seal can't use this border crossing point.

Passengers under procedure or administration may leave the designated place only with the permission of the administrator.

### 6. Designated area for police control

- ➤ Pedestrian traffic of persons who have right to free movement and third country nationals take place next to the passport control cabin on the pavement.
- Pedestrian control in case of suspicion: waiting room.

- ➤ Border checks of vehicle and passenger traffic who have right to free movement and third country nationals take place next to the passport control cabin.
- ➤ Border checks of vehicle carried out on the basis of suspicions in a separate place on the exit side, next to the exit lane, on the entrance side, at the inspection post next to the crossing point building.

#### Designated area for customs control

- ➤ Pedestrian traffic- in designated area- take place next to the passport control cabin on the pavement.
- > Customs control of cars take place between passport control cabin and customs control cabin, in case of suspicion on the second line check place.
- ➤ Persons control in the case of second line check take place in the waiting room. Cars control in case of the second line check take place next to the office building.

#### Designated area for customs administrations:

- ➤ Designated area for customs administrations is located in the building of the crossing point (waiting room).
- > The passengers who want to cross the border during the administration can park in the exit parking lot.

## 7. The rules of entry into the border crossing point,

- To enter the border crossing point is permitted: only the aim of crossing the border line, and the aim of working.
- To leave control line is only authorized with the permission of customs officer, after the inspection of police and customs.
- For maintaining the ordered conditions at the border crossing point the police take action against the pedestrian who don't wait for entry but cross the border line.

### 8. Prohibited on the area of the Border Crossing Point:

- To spread litter, to pollute the environment.
- To use the buildings of the BCU not properly, to damage, to put them out of action.
- To take the photos or prepare sounds record without a permission.

#### 9. Smoking is prohibited on the buildings of the Border Crossing Point

Smoking is authorized only in the smoking area of the BCU. Smoking areas are:

- On the exit lane next to the secondary examination area.
- On the entry lane behind the office, next to the garbage collector.

The officers on duty are responsible for keeping the order of the BCP observed.
