**ABSTRACT FROM THE REGULATIONS OF THE
BEREMEND PUBLIC BORDER-CROSSING POINT OF THE POLICE OFFICE OF
SIKLÓS**

The road border crossing border with part of the order, ensure standards, restrictions or prohibitions that reside in border traffic on the road crossing points through:

- a.) people, limit next stepping of vehicles and cargo selective control
- b.) of border and transportation security
- c.) carry out the duties set out in international treaties
- d.) involved in border traffic audit bodies of continued cooperation.

The road to the border crossing point impeding traffic and its control activities can't continue.

The 1994th XXXIV. Act (Police Act) 1 § (2) 11 on the basis of the border carried out by the police or the border post order for the maintenance of a police officer.

Allow to stay at the road crossing 330 / 2007th Into (December 13th) on account of regulation.

The road border crossing opened for international traffic road border crossing, which controls the international passenger, vehicle and freight continuous opening times, home area, separate placement standing still. The border crossing of the state border and all vehicles (cars for vehicles to 3.5 tonnes gross vehicle weight of not more), as well as cyclists and pedestrians exceeded.

The area of the road border crossing: From the home land border crossing warning sign designated area between the entrance and part of the border fence restricted area. The territorial jurisdiction shall be included in the crossing diagram.

The road border crossing of persons, vehicles and control of shipments and migrate border - unless the absence of an international treaty or law - of the road border crossing in order of arrival.

The governing road border crossing roads, so road users in the field of road traffic regulations. For safety reasons, the vehicle's engine during the vehicle inspection, research should be stopped.

The passenger traffic of passengers and vehicles on the classification of early warning signs, lights, road markings or passport on the basis of the operating lever for come into the territory of the road border crossing.

The only road border crossing for the purpose of crossing the state border, and - 330 / 2007th (December 13) Decree 2-3. Personnel except those listed in § authorizing entry and residence permits can enter. The Border Police Department Police Siklósi single entry and residence in the road border crossing may authorize. Not for the purpose of crossing the border entry, stay, departure order of the detailed rules for the 330 / 2007th (December 13) Decree 4-7. Of § determined.

Parking enforcement at the border:

Parking lot designated staff parking sign on the west side of the crossing can park service vehicles to the road border crossing was installed organs, from organs superiors , working on the road border crossing of persons and for official purposes and administration of the crossings arrived persons, traveling visa to be admitted , and redirected passengers waiting vehicles.

In respect of passengers waiting at road crossing - diplomatic and persons and their entourage, semiconductor, and host delegations, indicated and except for authorized persons with respect to a subject - neither people nor vehicles are not allowed.

Flyer distribution, an authorized person is not allowed to perform for border crossing. The license (badge) to the upper clothing, in a visible place to pay. The activity does not interfere with the traffic order and road border crossing. Place and method of delivery of the publications is determined by the Border Police Department Beremendi Siklósi Police Service Commander.

Smoke throughout the crossing should only be at the designated area, no any other place!

The way public announcement of a proposal , in response to complaints the way place to make your vehicle licensed or to the way the administration building road border crossing stay at the forefront of the service park.

The road border crossing cleanliness and order everyone is obliged to keep, keep. Anyone who violates the rules of border crossing followed by the offense, including on the basis of the existing law on offenses with a warning, or a site liable for infringement proceedings initiated against him.
