Extract from the order of Berzence Land Border Crossing-point

- 1. Berzence Land Border Crossing-point locates on the common border between Hungary and Republic of Croatia, and ensures the opportunity to cross the border of international passenger-, freight-, and cargo traffic in 24 hours per day business hours. The requirements of border check on the border crossing-point have been fulfilled by the Hungarian and Croatian police authorities, in the so called one-stop checking system. The border crossing-point locates on the area of responsibility of Somogy County's Police HQ, Nagyatád Police Station.
- 2. Concerning the type of vehicles, the border crossing-point and the state border are allowed to cross by all types of vehicles exception the vehicle, which one is heavier, than 20 tons , furthermore by bicycle or on foot.
- 3. Border check and transfer of passengers and vehicles have been performed in the succession of their arriving, except in case of other direction written in law or international agreement.
- 4. The state border is passable in case of presence of passing conditions declared in laws. The check of border-traffic on the land border crossing-point has been done on the spot of check, at the line of police control. The Hungarian and Croatian police receive the passenger and vehicle at the front-side of the cabin and take the identification of the person and the checking of documents. The technical control of documents, the border registration and the record of statistical data have been accomplished inside the cabin. On the exit side the Hungarian police officer in duty takes over first the passenger's documents and hands over them after his/her check to the Croatian police officer in duty. The Croatian police officer in duty gives back the document to the passenger after his/her check. On the entry side the Croatian police officer in duty takes over first the passenger's documents and hands over them after his/her check to the Hungarian police officer in duty. The Hungarian police officer in duty gives back the document to the passenger after his/her check. Passengers, vehicles and cargos take part in the border traffic are allowed to continue their journey after the permission of the Hungarian and Croatian police.
- 5. The entry or exit of passengers and transit of vehicles is based on the check and approval of the Hungarian and Croatian police authorities taking part in the border check.
- 6. The order of border crossing-point has to be observed by each one of persons, who is staying or travelling across on that.
- 7. The document, which contains the order of border crossing-point in details in Hungarian language shall be submitted by the commander in charge of the border crossing-point to the claimant after his/her request.
- 8. On the border crossing-point closed-circuit video surveillance system operates it has been reported to and administered by the supervising authority and in continuous operating the system is recording and storing pictures and videos.

Main legal bases of the Order of Border crossing-point are the followings.

- II. Act XXXIV of 1994 on the Police
- III. Government Decree 332/2007 (XII.13.) about the opening and operating of border crossing-point and temporary border crossing-point and about border—points.
