**ABSTRACT FROM THE REGULATIONS OF THE
DRÁVASZABOLCS PUBLIC BORDER-CROSSING POINT OF THE POLICE OFFICE
OF SIKLÓS**

The regulations regarding public border-crossings are part of the general frontier regulations, which ensures:

- a.) For natural persons, vehicles and shipments to cross the frontier while performing selective control;
- b.) The safety of the border traffic and transportation;
- c.) The execution of the tasks undertaken in international treaties; and
- d.) The cooperation with other organizations that control the frontier

by means of regulations, limitations or prohibitions regarding the border traffic and the stay at the public border-crossing.

It is prohibited to undertake any activity at the public border-crossing point that would hamper the border traffic or the control thereof.

Based on Sub-section 11 of Section (2) of Paragraph 1 from the XXXIV Act of 1994 (also referred to as „Rtv.”) the Police controls the border traffic and responsible for the order of the border-crossing point.

Whether the stay at the public border-crossing point is to be permitted will always be judged based on the regulations of the Decree of the Government No 330/2007 (13 December).

In the territory of the public border-crossing point required to comply with the rules of the road. During the car checking and search switch off the engine.

The public border-crossing point is open for international traffic, and it controls the international traffic of natural persons, vehicles and shipments 24/7, at its own territory, at own emplacement, in standing position. Regarding the means of transport used to enter the territory of the border-crossing point as well as to cross the border, all kinds of vehicles, as well as bicycles are permitted, and moreover, it is also possible on foot. At public border-crossings, the control of natural persons is at the control point on the lane for border control, separate from Croatian Police.

The **territory of the public border-crossing point**: the restricted (by fence) territory between the signpost for border-crossing standing at the home side end of the bridge and the signpost for border-crossing point placed at the side directing to the municipal of Drávaszabolcs.

Only persons with the aim to cross the national border and those with special admission entitlement determined in separate regulations or with adequate permission are permitted to stay at the territory of the public border-crossing.

The border-crossing control of the personal persons, vehicles and shipments and the authorization of the border crossing would always be performed on a “first come first served” basis, unless an international treaty or regulation orders it differently.

Regarding the **border-crossing of passengers traffic**, the passengers and the vehicles are permitted to enter the territory of the public border-crossing by virtue of the traffic signs, lights, and road markings indicating the categorization or upon arm signals from the frontier officer.

In case of **border-crossing traffic of shipments**, it is always the frontier officer who lets the vehicles and the passengers into the territory of the border-crossing, and also lets them out.

The vehicle traffic at the public border-crossing is regulated by means of the traffic signs, road markings and signs, lights, as well as through the arm signals from the border officer controlling the traffic.

Only persons with the aim of crossing the national border and persons having a valid admission and residence permit are permitted to enter the territory of the public border-crossing, with the exception of the persons explicitly named in Paragraph

2 and 3 of the Decree of the Government No 330/2007 (13 December). The Police Office is entitled to give permission for a one-time entry into and stay at the territory of the border-crossing. The regulations applicable to the entry, stay and leave with aim different from border-crossing are formulated in Paragraphs 4-7 of the Decree of the Government No 330/2007 (13 December).

Parking regulations at the border-crossing point:

The officer parking place at the eastern side of the border-crossing point can be used for:

- The official vehicles used by the organs resident at the territory of the border-crossing point, as well as the superiors' vehicles who are visiting these organs;
- The vehicles of the natural persons working at the territory of the public border-crossing point;
- The vehicles of the natural persons entering the territory of the border-crossing point on official matters, to arrange official administrative tasks;

The vehicles of passengers waiting for the issuance of visas; and the vehicles of passengers that need to be turned back and vehicles staying for a shorter period of time, e.g. to buy foreign currency, to buy national sticker for the vehicle, e-toll, motorway vignette or to use the rest room need to be directed to the lanes with no traffic or to the sites dedicated for secondary line control.

Neither natural persons nor vehicles are permitted to stay at the territory of the public border-crossing with the object of waiting for passengers, with the exception of diplomats or similar natural persons including their accompaniment and the persons responsible for the reception of delegations, possessing adequate permission.

Persons possessing adequate permission for stay without the aim of crossing the border are permitted to distribute flyers. The permission (pin) needs to be worn on the over clothes, and needs to be visible. The activity should under no circumstances hamper the order and traffic of the public border-crossing point. The place and mean to handle over the flyers are determined by the duty officer.

Smoking is prohibited on the entire territory of the border-crossing point, except from the places especially dedicated to that. The infringement of the regulations effective at the border-crossing point results in petty offence, which can lead to on-the-spot fine or to accusation.
