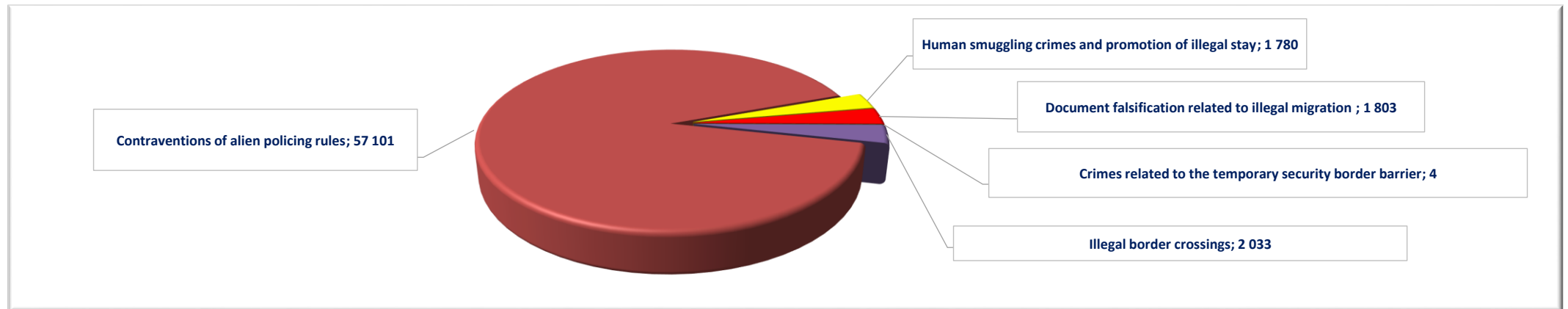
Number of unlawful acts related to illegal migration in a day 2022. I-XI.

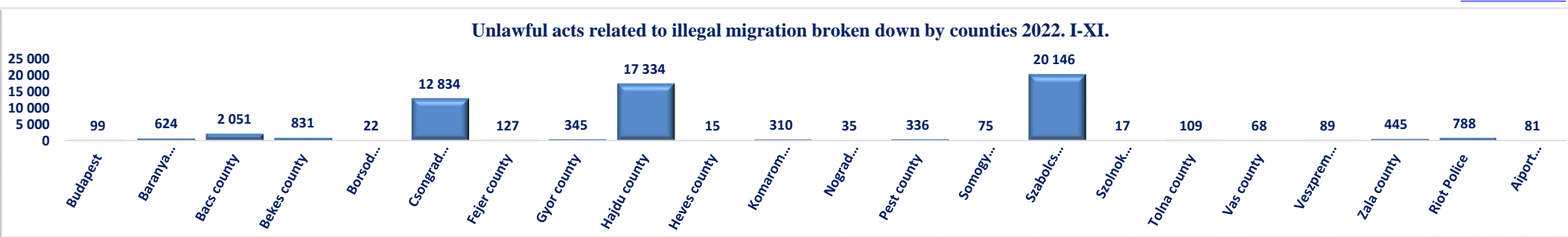

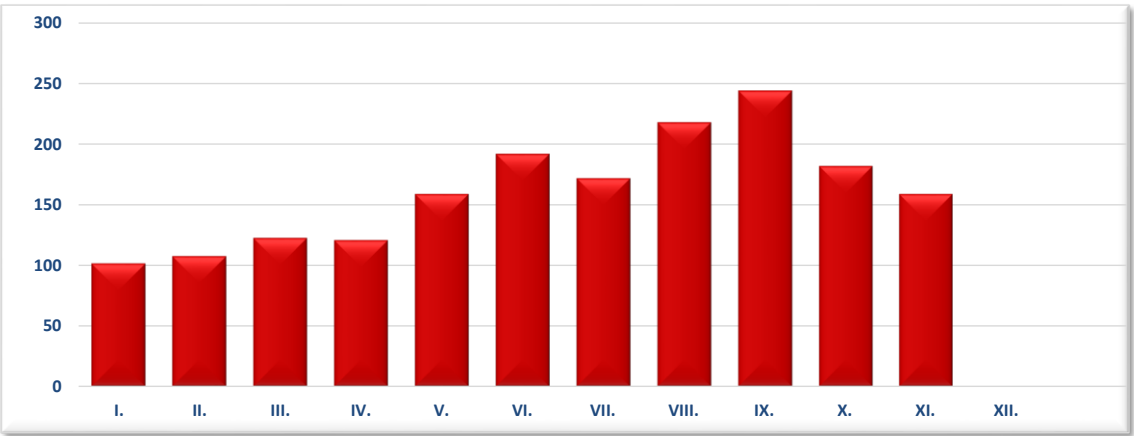

Smuggling of human being crime and promotion of illegal stay 2022. I-XI.

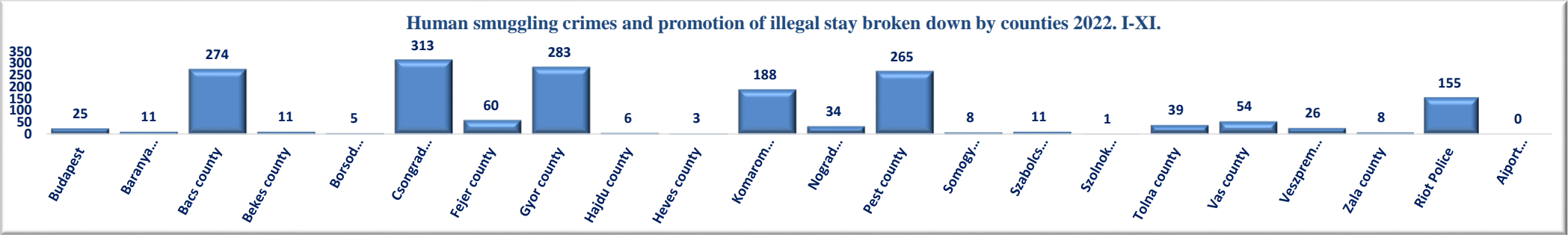

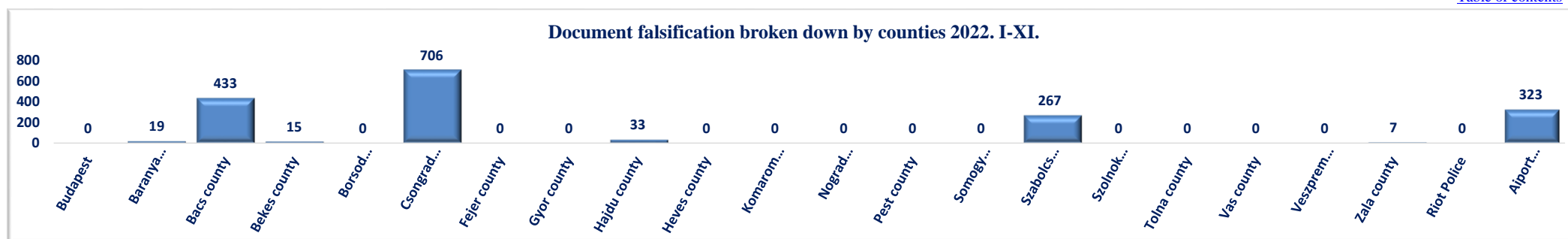
Document falsification related to illegal migration in a day

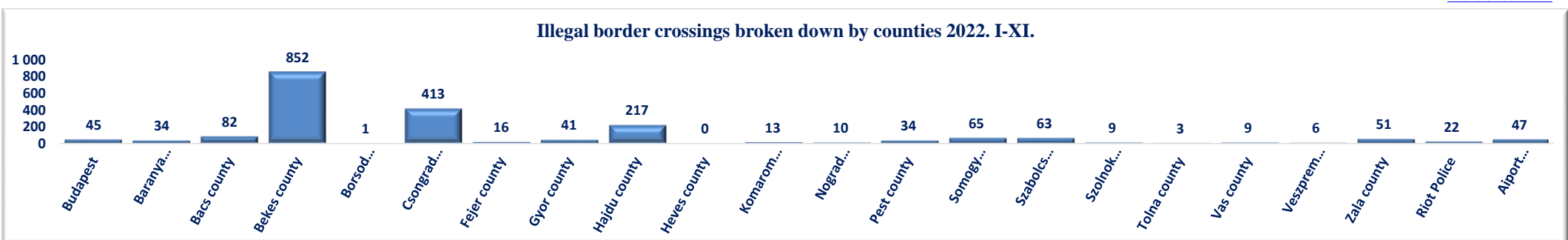
Number of illegal border crossings in a day

Number of contraventions of alien policing rules in a day

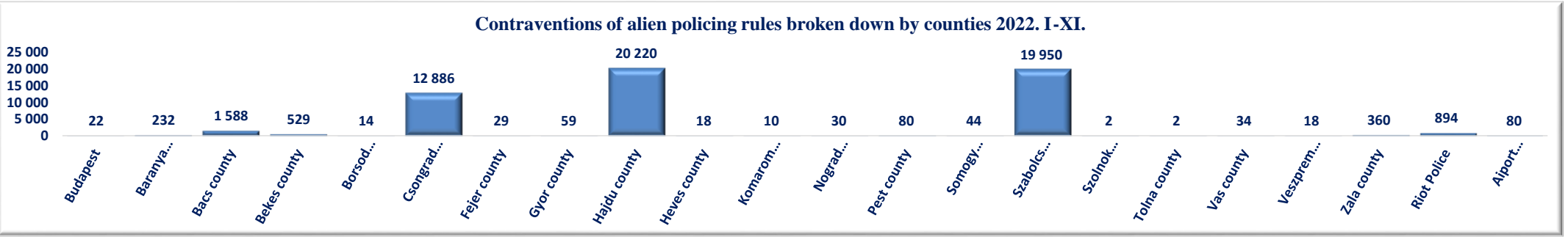

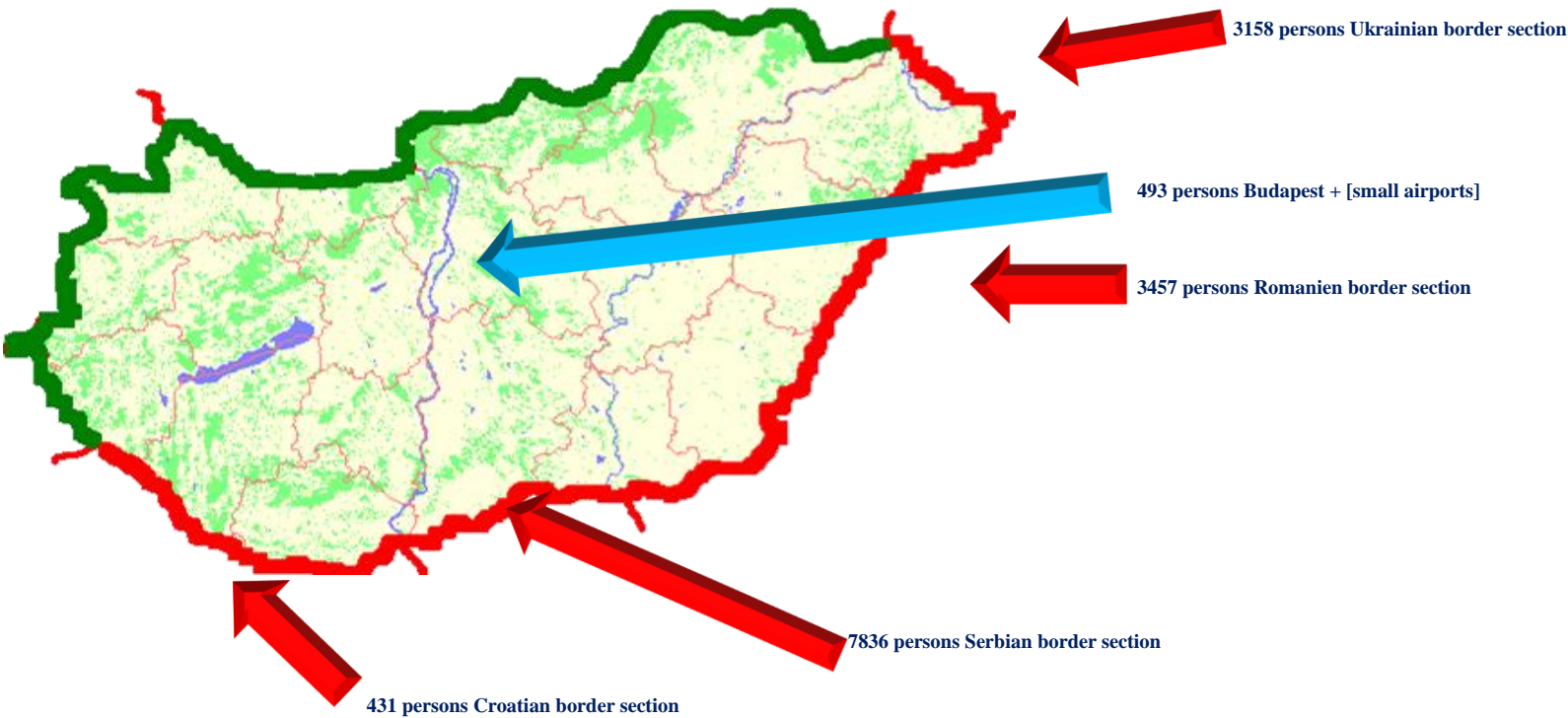

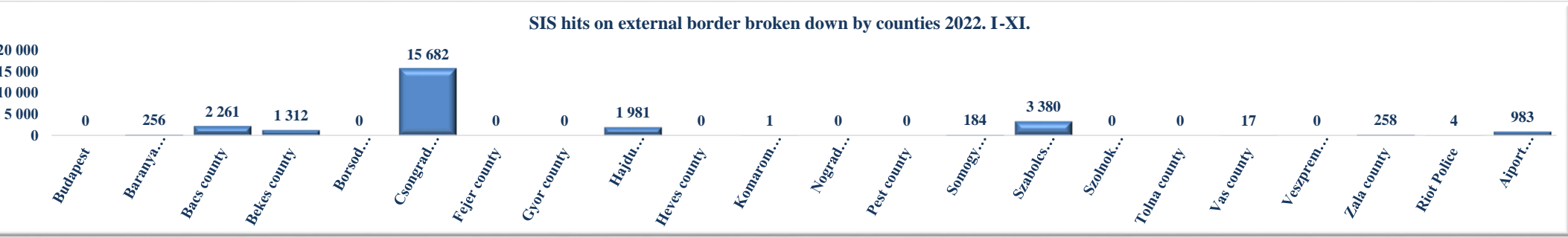

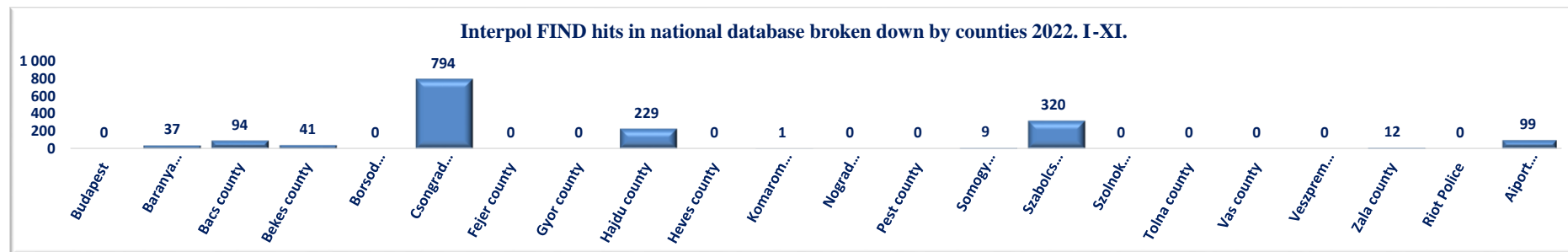
