Number of unlawful acts related to illegal migration in a day 2025. I-III.

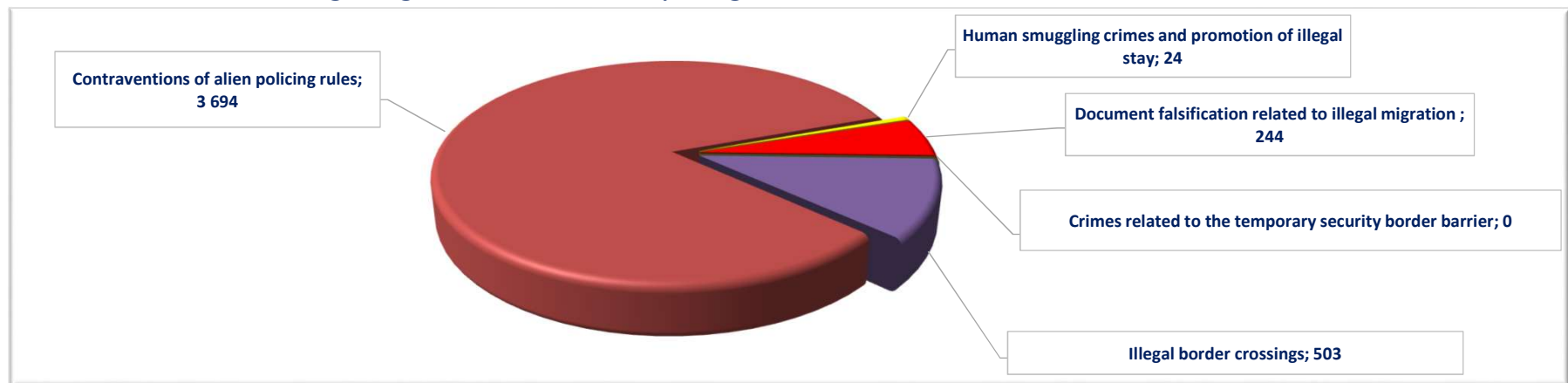

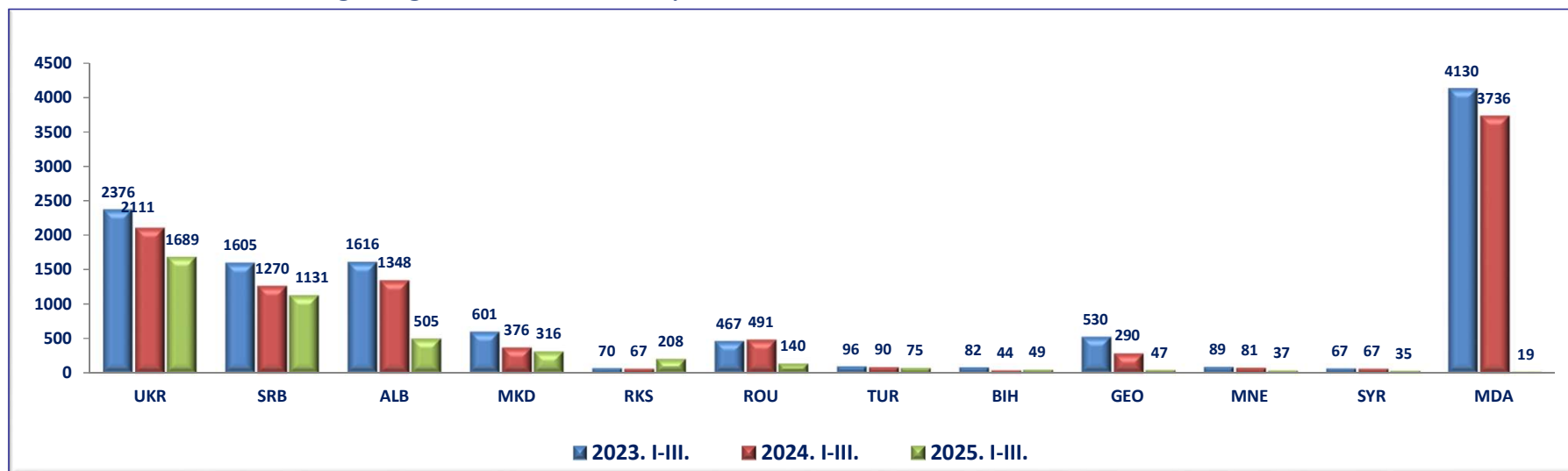

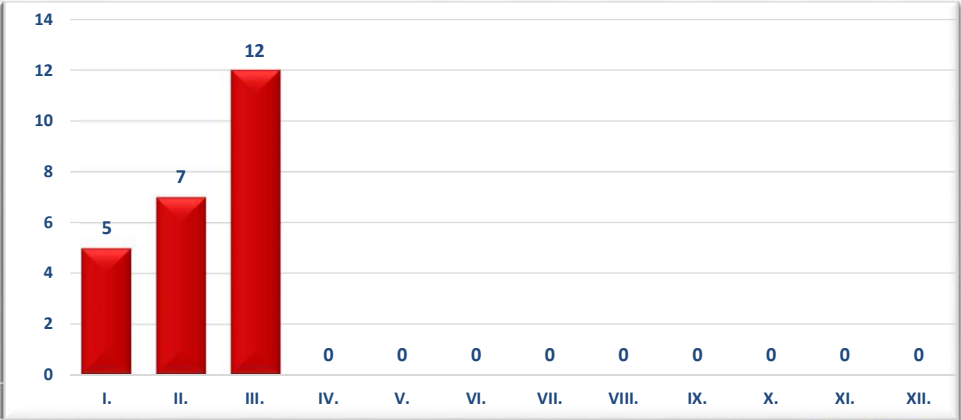

Smuggling of human being crime and promotion of illegal stay 2025. I-III.

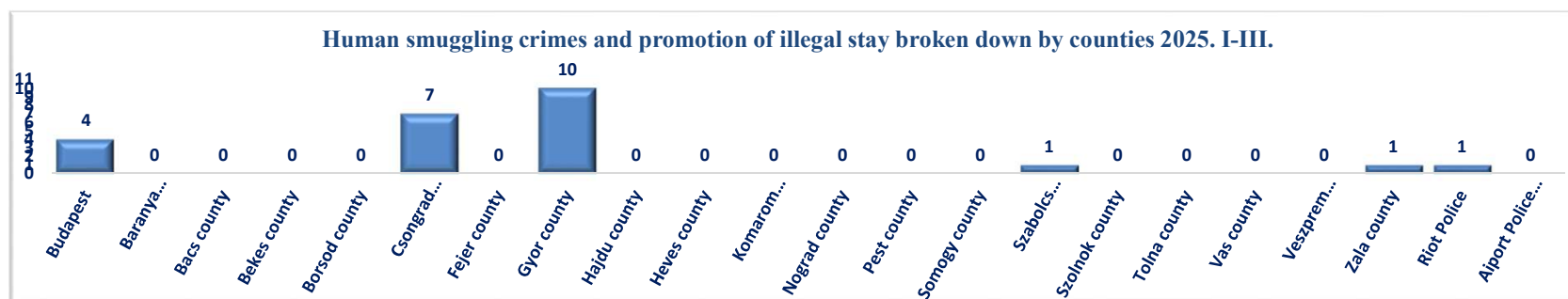

Document falsification related to illegal migration in a day

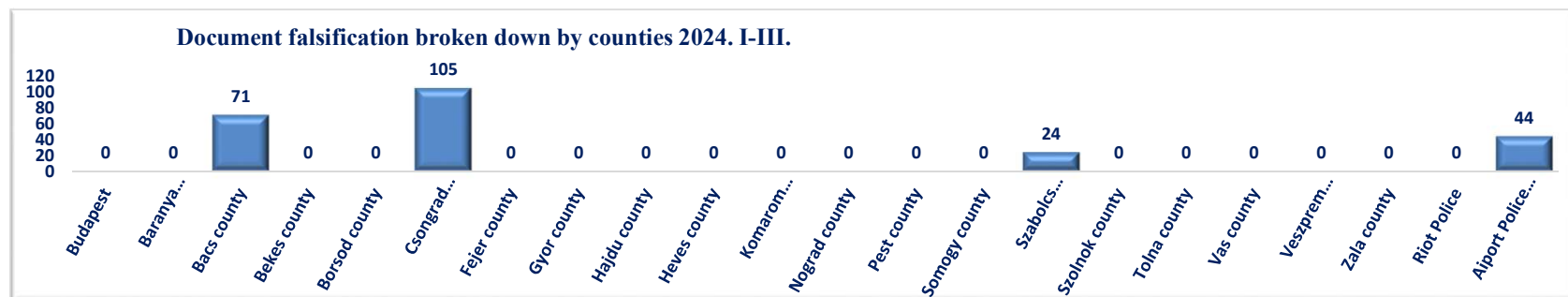

Number of illegal border crossings in a day

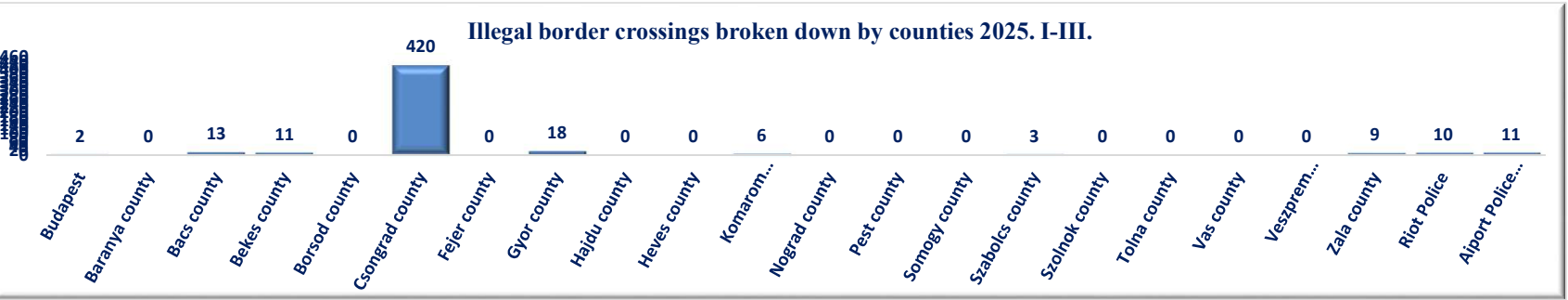

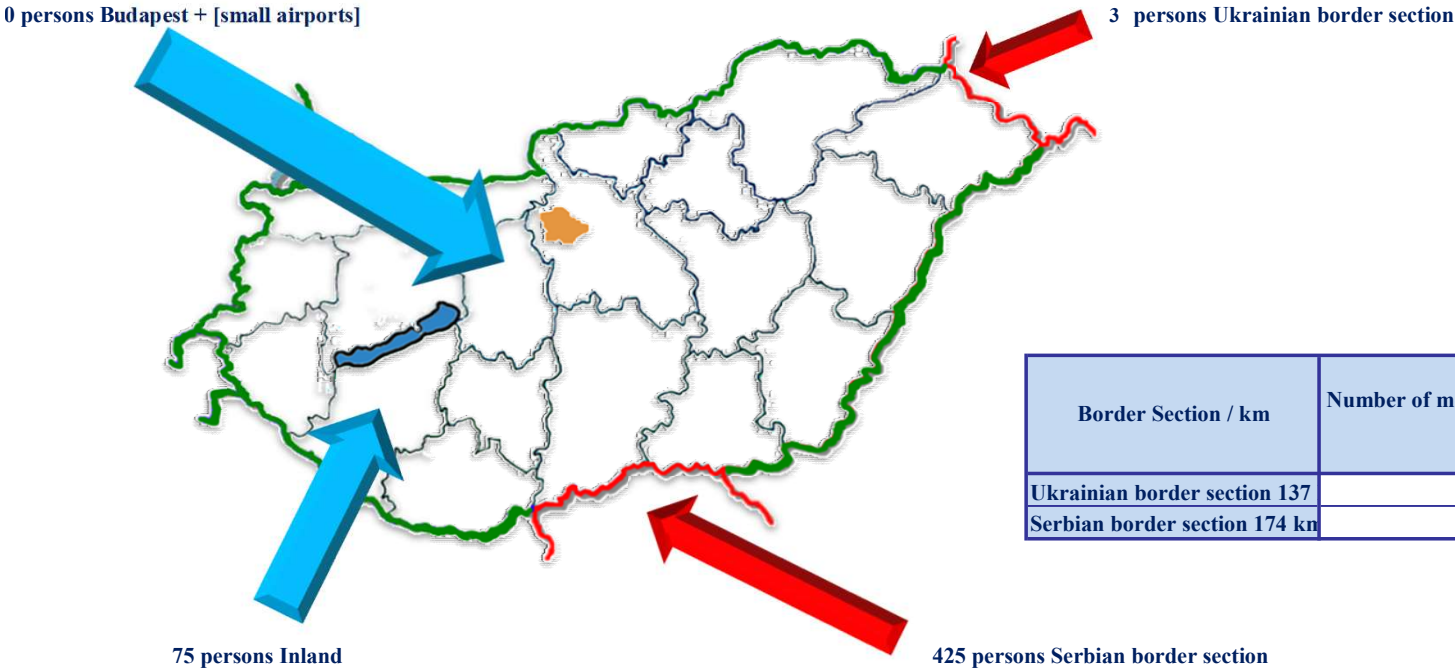

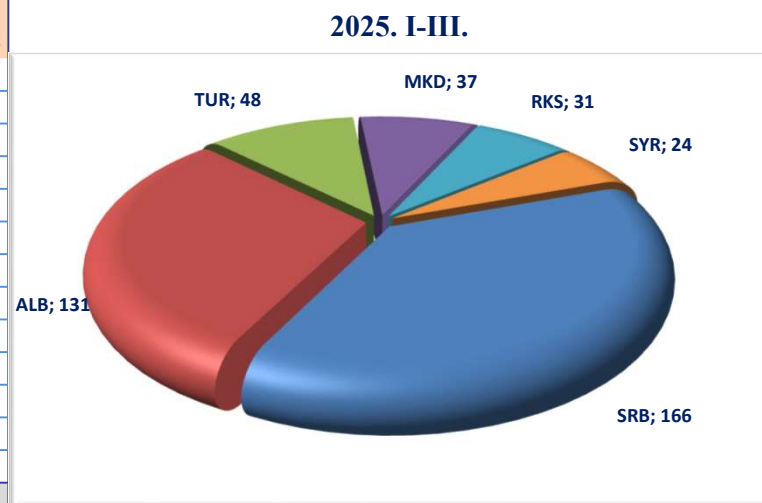
Illegal border crossings broken down by border sections

Number of contraventions of alien policing rules in a day



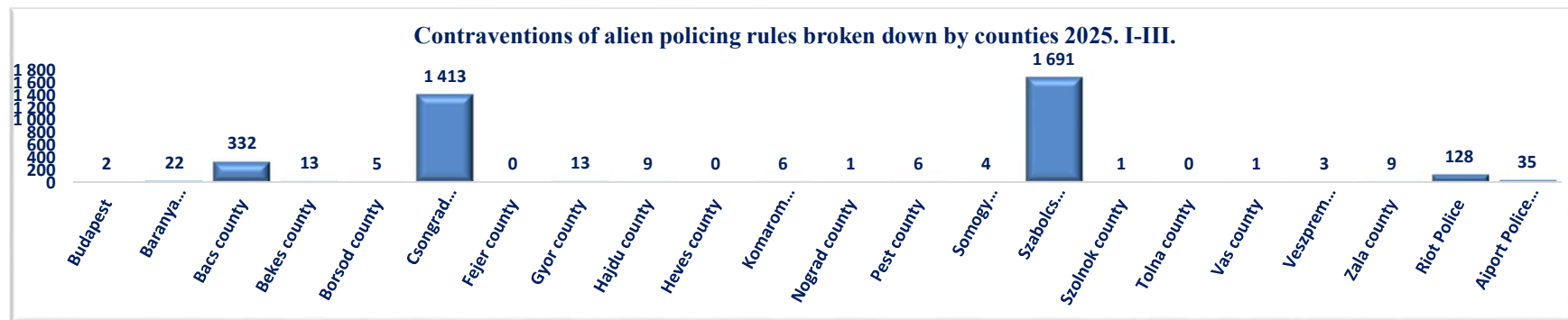

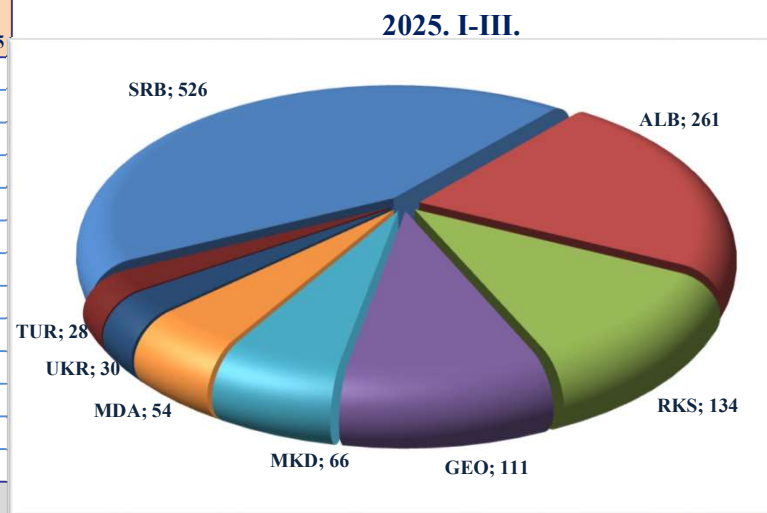
Main reasons of returns broken down by border sections

Number of warrant of captions in a day



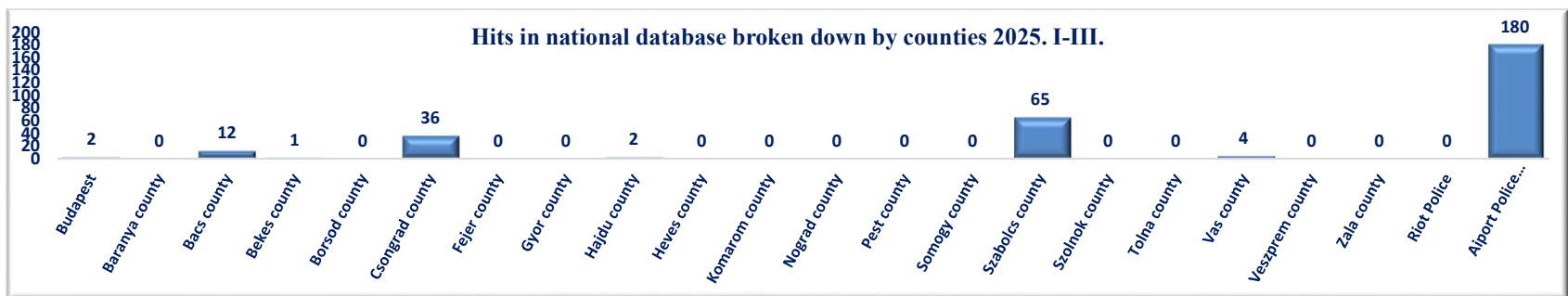

Number of SIS hits in a day



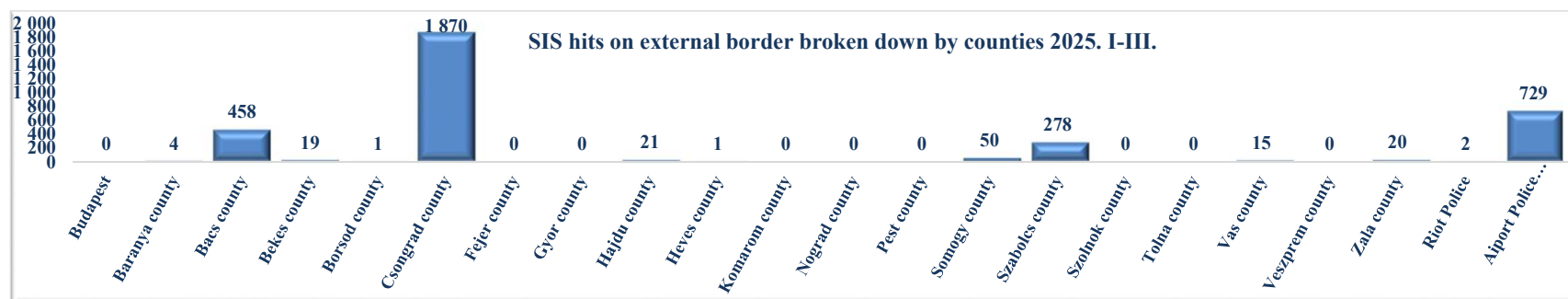
