

THE ORDER OF THE ZÁHONY RAILWAY BORDER CROSSING POINT

Legal background:

- Regulation (EU) 2016/399 of the European Parliament and of the Council of 9 March 2016 on a Union Code on the rules governing the movement of persons across borders (Schengen Borders Code)
- Act XXXIV of 1994 on the Police (hereinafter Rtv)
- Act I of 2007 on the entry and residence of the persons enjoying the community right of free movement and residence (hereinafter Szmtv)
- Act II of 2007 on the entry and residence of the third-country nationals (hereinafter Harmtv)
- Decree 330/2007 (XII. 13.) on the frontier, as well as on the rules regarding the persons arriving at the border crossing point with no intention to cross the border
- International treaties and agreements, Internal regulations related to the control and implementation of activities at the border crossing point

I. The order of the road border crossing point (hereinafter BCP):

The order of the BCP contains all the regulations, which must equally be observed by the officials performing duties and every individuals who are taking part in the passenger and cargo traffic or arriving at the BCP with no intention to cross the border.

The order of the BCP is part of the ordered conditions at the border.

With the help of the regulations, restrictions and prohibitions concerning the border traffic and the stay at the BCP, the order of the BCP ensures:

- a. the quick, efficient and smooth check of the passengers, vehicles and consignments.
- b. the safety of the border traffic and road transport
- c. the implementation of the tasks assigned by international treaties
- d. the continuous cooperation with other authorities taking part in the control of the border traffic

Any activities at the BCP, which may obstruct the border traffic flow and the border checks, are forbidden.

II. General characteristics and implementation of the border control:

The border crossing point is non-stop open for international railway passenger and cargo traffic, with continuous visa issuance service.

Method of border checks: individual

Passenger categories may cross the border:

- Individuals travelling with passports in international traffic, in accordance with the provisions of the visa agreements
- Based on international treaties, individuals who are crossing the border in international traffic with other documents

III. Order of the control and passage:

The order of the border checks on both directions:

1. Check of the travel and other documents by the Police
2. Customs control carried out by the NTCA

The police and customs checks carried out on board the train, within the scheduled waiting time of the train.

The passengers are obliged to present their travel documents to the controlling officers.

Boarding or leaving from the international trains allowed only upon permission given by the Police or NTCA representatives to do so.

IV. Places designated for control:

The Police begins the checks and the search of the cargo trains (both on entry-exit) from the direction of inland towards the state border, the check of the passenger trains begins according to the decision of the Police duty officer, in order to avoid train delays.

V. Rules of entry and stay in the territory of the border crossing point:

Due to complexity of the activities at the railway border station, the entry and stay of persons without intention to cross the border requires a special interpretation.

Definition of the border area: the board of the international train during the period of the control, the places designated for the control of passengers and consignments, moreover the departure, arrival and storage tracks, including their platforms.

The entry into the territory of the border crossing point (including the platforms and trains under control) is possible only for purpose of crossing the state border, carrying out border checks, working, or for controlling the above activities.

Persons other than those defined above may enter the area of the border crossing point only with special permission and may stay there only for the period specified in the permit.

VI. Other provisions:

1. By the applicable law, the Police may apply sanctions against the persons violating the regulations set by the Order of the BCP.
